BEFORE COMPLETING THE DECLARATION

ALL APPLICANTS MUST READ SECTION 21 OF THE FIREARMS ACT(quoted as follows):-

Section 21 of the Firearms Act 1968 - *This section applies to anybody who has been sentenced to imprisonment or to youth custody or detention in a young offender institution for three months or more. The period for which they are prohibited depends on their length of sentence - if the sentence was longer than three years, the prohibition is for life. If the sentence was three months or more, but less than three years, the prohibition lasts for five years from the date of their release. It is an offence for a person to transfer, let or hire, give or lend a firearm or ammunition to someone who he knows or has reasonable grounds for believing to be prohibited by Section 21 of the Firearms Act 1968.*

DECLARATION

I understand Section 21 of the Firearms Act 1968 and declare that I am not a prohibited person in relation to this Act. I undertake to immediately inform the Club if I become a prohibited person.

I certify that the information which I have given on this application is correct and complete.

If my application is accepted, I agree to abide by the Constitutional Rules of the Club as amended from time to time. A copy of the current rules is displayed in the Club House. I also agree to help with the maintenance of the Club premises and the range facilities.
