BEFORE COMPLETING THE DECLARATION

ALL APPLICANTS MUST READ SECTION 21 OF THE FIREARMS ACT (quoted as follows):-

Section 21 of the Firearms Act 1968 - This section applies to anybody who has been sentenced to imprisonment or to youth custody or detention in a young offender institution for three months or more. The period for which they are prohibited depends on their length of sentence - if the sentence was longer than three years, the prohibition is for life. If the sentence was three months or more, but less than three years, the prohibition lasts for five years from the date of their release. It is an offence for a person to transfer, let or hire, give or lend a firearm or ammunition to someone who he knows or has reasonable grounds for believing to be prohibited by Section 21 of the Firearms Act 1968.

DECLARATION

I understand Section 21 of the Firearms Act 1968 and declare that I am not a prohibited person in relation to this Act. I undertake to immediately inform the Club if I become a prohibited person.

I certify that the information which I have given on this application is correct and complete.

If my application is accepted, I agree to abide by the Constitutional Rules of the Club as amended from time to time. A copy of the current rules is displayed in the Club House. I also agree to help with the maintenance of the Club premises and the range facilities.

DATA PROTECTION Addiscombe Rifle Club complies with the General Data Protection Regulations: the Club's policy can be obtained from the Secretary. To avoid unnecessary costs the Club needs your explicit consent to contact you and to hold, process, and disclose details relevant to your application and membership. The information held is purely that relevant to your membership, and disclosure of such information is normally restricted to the Club's committee. There are certain exceptions to this,

1. To generate membership lists for subscriptions and attendances, and to record payments and attendances

2. To supply details of ability, either by class or average, to third party league and competition organisers

3. To supply information covered in the statutory and rule of law definitions in the General Data Protection Regulations and the Data Protection Act, which are exempt from the non-disclosure rules. Currently these only apply to our obligation to notify Membership and attendance figures to the Police Authority.

You are entitled at any time to request details of any personal data held by the Club. A nominal fee may be payable for such a request. The Secretary is the Club's representative under the Regulations and the previous Act.
